RE-NOTICE FOR EXPRESSION OF INTEREST (EOI) FOR CONDUCTING TRAINING COURSES WITH OJT

(Published on 13 January 2019 (2075/09/29))

- As per the first EOI notice published by ENSSURE Project on 5th November 2018 (2075 Kartik 19) for conducting training course with OJT, minimum required number of bidders' are not short-listed for further procurement process, (as per the Public Procurement Regulations 2064, Article 70), hence the project has published re-notice for Eoi submission to all eligible and interested bidders.
- The ENSSURE is a project of the Government of Nepal, financially supported by the Government of Switzerland. It is implemented under Council for Technical Education and Vocational Training (CTEVT) with technical assistance from HELVETAS Swiss Intercooperation. The objective of the project is to improve the living standard of Nepalese workers, particularly women and people from disadvantaged groups through continuous employment.
- The main objective of this assignment is to deliver quality skill training for the targeted beneficiaries, following the CTEVT professional curricula of 1696 hrs. that includes adequate on-the-job training which is to be conducted in the premise of the consortium partner industries.
- After completing the training, the participants will be appeared in skill testing Level-2 ensuring certification of at least 90% of the trainees and assist them for employment so that at least 80% of the graduates have sustainable and rewarding employment in trained occupations.
- The project invites EOI from eligible, experienced, and competent private training provider/s in consortium with industries for conducting training course as per the prescribed curriculum including on the job training and related soft skills. The occupation wise number of beneficiaries allotted for each State for the assignment is given below.

6. One training provider can propose training program only in **one** occupation and the training program must be conducted in the proposed venue/s only. Joint ventures are not allowed.
7. All the training events must be conducted in the training provider's legally registered training center/s having adequate training facilities for the proposed occupations. Conducting trainings in temporary settings are not allowed.
8. The training provider must have valid CTEVT affiliation to conduct the proposed training on related occupation.
9. The Trainings are expected to commence from March 2019.
10. The training provider with its consortium industries should submit duly filled EOI format according to the issued Terms of Reference (TOR) through e-bidding process. EOI format can be downloaded from e-GP system www.bolpatra.gov.np/egp or visit the client's website www.enssure.org.np, www.ctevt.org.np.
11. The selection process follows Quality and Cost Based Selection (QCBS) and will be in accordance with the Public Procurement Act 2063 and its amendments 2073 and Public Procurement Regulations, 2064 and its amendments 2068.
12. EOI will be assessed based on Qualification (40%), Experiences (40%), and Capacity (20%), of consulting firm and key personnel. Based on evaluation of EOI, only short-listed firms will be invited to submit technical and financial proposal through a request of proposal.
13. Minimum score to pass the EOI is 60 points.
14. Documents of the experience and other evidence copies of certificates shall be duly notarized.
15. Complete EOI documents shall be delivered online through e-GP system www.bolpatra.gov.np/egp on or before by 12:00 hours local time of 28 January 2019 (2075/10/14) In case of the last day of submission of EOI falls on public holiday, then the next working day and same time shall be considered as the last date.
16. CTEVT/ENSSURE reserves the right to reject any or all EOI with or without furnishing any reasons to the firms concerned.
